# **GOD-GIVEN UNALIENABLE RIGHTS OF ALL HUMANS**

The U.S. Constitution protects the God-given unalienable rights of humans, "among which are Life, Liberty and the Pursuit of Happiness" as written by Thomas Jefferson in the Declaration of Independence. The U.S. Constitution was written to protect God-given life ... "the right to be secure in their persons against unreasonable seizures...nor shall any person be deprived of life or limb without the due process of law...no cruel punishments shall be inflicted". [Articles 4,5 & 8]

When Michigan was a Territory, the death penalty was banned for any non-wartime crime. When admitted as a State in 1847 the State Constitution continued to ban the death penalty and banned death by abortion except to protect the life of the mother. In the current Constitution of Michigan it protects life "No person shall be deprived of life or liberty without due process of law...the accused shall have an appeal as a matter of right...no stem cells may be taken from human embryos more than 14 days after cell division begins." [Article 1. Sections 11, 20 & 27] Now we are faced with local school boards, townships, libraries and counties allowing abortion by voting to use tax dollars to pay the insurance for these deprivations of life, these seizures, these cruel punishments without due process and without appeal. In every case the living human committed no crime and was not convicted by a Court beyond a reasonable doubt by a jury of their peers.

Right to Life supporters should pray about becoming more involved at the local level. Read, ask questions, get statistics and know if your tax dollars are spent on procedures that are a cruel punishment to the innocent [often cloaked as "reproductive health coverage"]. RTL Livingston County has the resources, mentors and contacts to support volunteers, candidates for office, advocates and social media users. Give it some thought then put your energy into sustained action. Be a voice for the voiceless.

**December 23, 2019:** Michigan Values Life coalition turns in 379,419 signatures to ban Dismemberment Abortions in Michigan

The Michigan Values Life coalition submitted **379,419** signatures believed to be valid to the Michigan Bureau of Elections to initiate legislation to ban dismemberment abortions in Michigan. The legal signature requirement for citizen-initiated legislation in Michigan is 340,047. RLM President Barbara Listing said, "Our committed all-volunteer force persevered through significant obstacles that kept being put in their path this year. We've received more than 400,000 signatures, but after thorough checking, we've whittled it down to our final total of valid signatures." Each petition received has been checked at least four times.

The Bureau of Elections will take several weeks to determine the validity of the submitted signatures, and once enough signatures are confirmed the legislation will be sent to the Michigan Legislature. The Legislature will have 40 days to consider the dismemberment ban, which after successful majority votes will become law without Governor Gretchen Whitmer's signature. Initiated legislation that isn't passed into law is placed on the general election ballot for a public vote. The dismemberment ban bills include an exception if the mother's life is in danger. However, in published research on reasons women have abortions, the proabortion Alan Guttmacher Institute has stated that most late-term abortions are done for economic or social reasons.

# GOVERNOR WHITMER'S REPRODUCTIVE HEALTH ACT EXPLAINED

—From Right to Life of Michigan Press Releases October 29 and November 4, 2019



Governor Gretchen Whitmer and pro-abortion allies held a press conference to unveil what they call the Reproductive Health Act. The New York-style act would allow unlimited abortions in the state of Michigan up to the point of birth. During the October 29 press conference remarks Governor Whitmer also criticized Right to Life of Michigan's petition drive to ban dismemberment abortions.

Governor Whitmer said, "They've already passed a bill to ban a safe procedure that has saved women's lives. And as they know, I'm going to veto those bills if they ever have the backbone to send them to my desk."

The following statement is from Right to Life of Michigan **President Barbara Listing:** 

It's no surprise that Governor Gretchen Whitmer wants to follow New York's lead and allow unlimited abortion-on-demand in Michigan...

Governor Whitmer claims our petition drive to end dismemberment abortions is banning a 'safe' procedure. There's nothing safe for a child during the later stages of pregnancy when her arms and legs are torn off by forceps, and her body and skull crushed and removed. The bill to end dismemberment abortions has a life of the mother exception, so her rhetoric is as empty as her compassion for viable children who can survive outside the womb.

Prolife people have plenty of backbone, which is why we **continue to collect** 400,000 signatures on a bill to end the dismemberment abortion procedure that rips backbones out of viable children. Most Americans do not support late-term abortions, and it's time for Governor

Whitmer to respect that Michigan values life.

The bills making up Governor Whitmer's Reproductive Health Act (RHA) were introduced into the Legislature on October 31. The main bills <u>SB 622</u> and <u>HB 5179</u> are identical, and the other bills in the RHA remove sentencing or references to laws it would repeal. Right to Life of Michigan staff have analyzed the changes to Michigan law. The bills will allow unlimited abortion and undo decades of our work in Michigan.

#### MAJOR CHANGES

- Repeals Michigan's complete abortion ban and codifies an unlimited health exception in state law.
- Creates an unlimited right to abortion, which could have broad implications. Allows women to sue for damages if she believes that right is being restricted in any way.
- Repeals the partial-birth abortion ban.
- Nullifies the current petition drive to enact a ban on dismemberment abortions (which amends the partialbirth abortion ban).
- Allows abortion facilities to be unregulated and never be inspected.
- Removes parental consent requirements.
- Removes waiting periods and requirements that abortionists provide women with informed consent and an opportunity to see her ultrasound.
- **Removes** mandated screening for abortion coercion.
- Opens the door for any medical professional to perform a surgical abortion.
- **Stops** local governments and schools from regulating abortion in any way, including through zoning laws.

#### THE ENDORSEMENT OF CANDIDATES IN ELECTIONS

Here are a few facts and rules about the Right to Life of Michigan PAC endorsement process:

- Endorsements are NEVER given verbally
- Endorsements ONLY come in writing from RLM PAC (not the county Right to Life affiliate)
- The county PAC subcommittee solicits written answers on a Candidate Questionnaire and then conduct confidential in-person interviews
- The RLM-PAC receives recommendations from the county affiliate PAC subcommittee
- Endorsements in a primary may differ from the later general election
- Sometimes, no endorsements are made
- Voting records on prolife issues are important
- Partisan political party membership is irrelevant
- RLM-PAC reserves the right to RESCIND any endorsement at any time prior to an election or while a candidate is in office
- Non-endorsed candidates are discouraged from attempting or using RTL events to campaign



40 Days For Life is an internationally coordinated 40-day campaign that aims to end abortion locally through prayer and fasting, community outreach, and a peaceful all-day vigil in front of abortion businesses. 
