## FINAL THOUGHTS ABOUT THE ELECTION

Dear Friends,

This will be my final letter to 800,000 people before Americans cast our ballots on November 3rd. It is a breathtaking moment in the history of the United States... Many political commentators have stated that this election is the most significant since 1864, when Abraham Lincoln vied for a second term... The future of our beloved nation hung in the balance that year. If Lincoln had lost, the Civil War would have ended precipitously and the wretched evils of slavery would have remained legal in the Confederate States, and perhaps even in the North. Had Lincoln been defeated, the Union would have been torn asunder. Thank God Mr. Lincoln won, even though it cost him his life!

Now we are approaching another presidential election that carries enormous implications for the stability of our democratic system of government. Indeed, Newt Gingrich said that what we are facing now might bring an end to civilization as we have known it... Regardless, I believe his grave concern for our nation is valid. For centuries, America has stood as a shining light for liberty and freedom in our nation and around the globe. If we abandon our founding core values, the world will suffer for it. The binary choice before us is that stark.

How will Americans, and how will you, decide who to vote for as our Chief Executive Officer? I'm voting for every unborn soul that is at risk of being aborted... for freedom and the American dream...for good and against evil. I'm not just voting for one person. I'm voting for the future of my country!"*

I'm also voting for candidates who will exercise sound leadership internationally...for those who will support Israel... for those who will protect children from leftist curricula. I'm voting for the nation's fiscal integrity... for parental rights... for school choice and home education... for freedom in the suburbs. I'm voting for Little Sisters of the Poor and other Christian organizations... for racial unity. I am voting to support "In God we trust" and school prayer...



**Right to Life of Michigan did not challenge the Bureau of Elections’ recommendation that there were not 340,047 valid signatures in the Michigan Values Life petition drive to ban dismemberment abortions. Right to Life of Michigan President Barbara Listing shared the following message as part of a Press Release in June:**

*We know we submitted signatures from more than 340,047 registered voters. Instead of focusing on court challenges regarding the counting process, we will be focusing on the critical 2020 elections moving forward.*

*Our volunteers did an excellent job, but the bulk of the errors were things beyond our control. Because we were about 20,000 signatures short of our goal of 400,000, we left room for Planned Parenthood to pick us apart so they can continue profiting from dismembering babies. We must hit our goal next time we do a petition drive.*

*Our petition drive system works well in normal times, but this time we were forced to fight a series of unprecedented battles we did not choose.*

*The effort behind this petition drive was worth it and will carry forward. Thousands of volunteers were mobilized to educate more than 400,000 people about this barbaric abortion procedure.*

*This was our first attempt to end the dismemberment of babies in Michigan, and we will continue working until we end this form of violence and protect the lives of every unborn child.*

# PRESIDENTIAL CANDIDATES WHERE THEY STAND ON LIFE



## THE RIGHT TO LIFE

**DONALD TRUMP'S** views on abortion changed after seeing friends experience a crisis pregnancy. "It is my profound honor to be the first President in history to attend the March for Life. We're here for a very simple reason: to defend the right of every child, born and unborn, to fulfill their God-given potential!"

**JOE BIDEN** Despite opposing Roe v. Wade in the early 1980s, Joe Biden supports elective abortions at any point in pregnancy. In the U.S. Senate, Biden voted against the Unborn Victims of Violence Act, "Lacy and Conner's Law," which allows additional criminal penalties if a pregnant victim's unborn child is also harmed by a violent crime.

## ROE V. WADE AND THE U.S. SUPREME COURT

**DONALD TRUMP** President Trump followed through on his commitment to appoint justices who believe in the rule of law. He opposes Roe v. Wade: "The Supreme Court in 1973 based its decision on imagining rights and liberties in the Constitution that are nowhere to be found!"

**JOE BIDEN** promises to "codify Roe v. Wade" if it is overturned, allowing abortion-on-demand through all nine months of pregnancy. Biden led the U.S. Senate effort to "bork" (oppose) Supreme Court nominee Robert Bork in 1987, widely recognized as forever changing the partisan and vicious nature of Supreme Court nomination hearings.

## LATE-TERM ABORTIONS AND INFANTICIDE

**DONALD TRUMP** was the first presidential candidate to describe a late-term abortion procedure during a presidential debate. He supported efforts in Congress to ban late-term abortions and protect babies who survive botched abortions: "We should not be one of seven countries that allows elective abortions after 20 weeks. It goes against our core values."

**JOE BIDEN** repudiated his past support for partial-birth abortion bans during his presidential primary campaign for the 2008 election. He criticized the Supreme Court's ruling in Gonzales v. Carhart, which upheld the federal partial-birth abortion ban: "This is all code for saying, 'Here we come to undo Roe v. Wade!'"

## TAXPAYER FUNDING OF ABORTIONS

**DONALD TRUMP** President Trump was the first president to ever defund a portion of Planned Parenthood's budget directly. He has constantly supported the Hyde Amendment, which prevents direct federal taxpayer funding of abortion.

**JOE BIDEN** After intense criticism from fellow Democrats, Joe Biden repudiated his support for the Hyde Amendment. His health care plan will force taxpayers to pay for abortions: "That's why at the same time I announced that policy, I announced that I could no longer continue to abide by the Hyde Amendment." Biden now fully supports using tax dollars to pay for abortions.



# VICE PRESIDENTIAL CANDIDATES WHERE THEY STAND ON LIFE



## VIEWS ON ABORTION

**MIKE PENCE** supports legal protection for every unborn child: "I want to live to see the day that we put the sanctity of life back at the center of American law and we send Roe v. Wade to the ash heap of history."

**KAMALA HARRIS** supports abortion through all nine months of pregnancy. She is filibustering the Born-Alive Abortion Survivors Protection Act in the U.S. Senate, preventing a vote on this legislation to protect babies born alive after a botched abortion from being abandoned to die by abortion facilities.

## VOTING RECORDS

**MIKE PENCE** has a 100% rating from National Right to Life for his time as a U.S. House Representative from Indiana (2001 to 2013), and had a prolife record as Governor of Indiana (2013-2017).

**KAMALA HARRIS** has a 100% rating from the National Abortion Rights Action League for her time as a U.S. Senator from California (2017- present).

## JUDICIAL NOMINATIONS

**MIKE PENCE** criticized Chief Justice John Roberts recent abortion ruling in June v. Gee, calling it "a wake-up call for prolife voters around the country who understand, in a very real sense, the destiny of the Supreme Court is on the ballot in 2020."

**KAMALA HARRIS** criticized federal district judge nominee Brian Buescher in 2018 for his membership in the Knights of Columbus, suggesting the organization's prolife views disqualified him from serving as a federal judge. She criticized the nomination of Supreme Court Justice Brett Kavanaugh: "He was put on the Court through a sham process and his place on the Court is an insult to the pursuit of truth and justice."

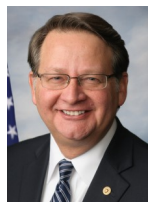
## FREEDOM OF SPEECH

**MIKE PENCE** supports the right to speak freely on the issue of abortion: "Freedom of speech is the bedrock of American democracy, that's why our founding fathers enshrined the freedom of speech, freedom of the press, in the first amendment of the constitution and I want all your listeners to know as they've seen this president and our administration take action to prevent online censorship in the past, that we're going to continue to lean into this effort."

**KAMALA HARRIS**, acting as the California Attorney General, directed a raid of the home of David Daleiden, the undercover journalist who exposed Planned Parenthood's human organ trafficking practices, to seize his recordings and video evidence before they could be released publicly.



# U.S. SENATE CANDIDATES WHERE THEY STAND ON LIFE



## VIEWS ON JUDICIAL NOMINEES

**JOHN JAMES** "I will fight to preserve separation of powers...and will approve justices who will interpret the constitution as written."

**GARY PETERS** voted against U.S. Supreme Court Justices Neil Gorsuch and Brett Kavanaugh, criticizing them for not supporting abortion.

## VIEWS ON PROLIFE ISSUES

**JOHN JAMES** has been endorsed by the Right to Life Michigan PAC in both of his only campaigns for office, stating he is 100% prolife.

**GARY PETERS** has never been endorsed by the Right to Life of Michigan PAC. His lifetime congressional scorecard from the National Right to Life Committee is 0%. During his time in the Michigan Legislature, Peters voted against any restriction on abortion and was a leading advocate for legalizing assisted suicide.

## VIEWS ON BORN-ALIVE BABIES

**JOHN JAMES** believes children who survive botched abortions have value as human beings and deserve legal protection: "Life begins at conception and ends at a natural death."

**GARY PETERS** is filibustering the Born-Alive Abortion Survivors Protection Act in the U.S. Senate, preventing a vote on this legislation to protect babies born alive after a botched abortion from being abandoned to die by abortion facilities.

## VIEWS ON PARTIAL-BIRTH ABORTION

**JOHN JAMES** has said he will fight against efforts to roll back laws protecting unborn children like the partial-birth abortion ban: "I want to speak for those who have no voice. I want to fight for those who can't fight for themselves and I can't imagine a more vulnerable group of people than our unborn children."

**GARY PETERS** voted three times (6/6/1996, 6/4/1998, and 5/6/1999) in the Michigan Legislature against a partial-birth abortion ban.

## VIEWS ON TAX-FUNDED ABORTIONS

**JOHN JAMES** opposes tax funding of abortion. He supports efforts to defund abortion providers like Planned Parenthood, which receives more than \$500 million tax dollars annually.

**GARY PETERS** has consistently voted for using tax dollars to pay for abortions. On December 3, 2015, Peters supported an amendment to make \$1 billion in tax dollars only available to Planned Parenthood and other organizations that provide abortions.
