Right to Life of Michigan President Amber Roseboom warned about the Michigan Death with Dignity bills:

“These bills are a misled attempt to save the state resources under the guise of compassionate care. The repeal of the state's longstanding safeguard against assisted suicide would put thousands of Michiganders at imminent risk of declining care and abandonment. Turning our backs on vulnerable citizens and patients in their hour of greatest need runs counter to the core mission of healthcare, ultimately denying patients true dignity, care and compassion.”

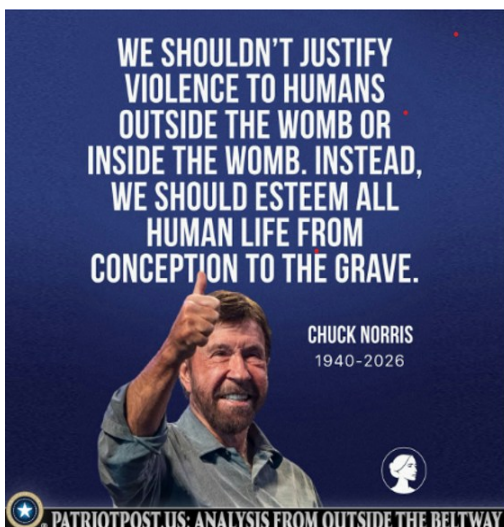

Right to Life - Livingston County Reaching Our Community & Beyond!

On May 23, RTLLC Board member and Making Life Disciples leader, Eliisa Seigle was able to speak at the Ius Vitae Monroe Walk for Life.

This event unites many Pro-life organizations in solidarity to educate people on the value of protecting the unborn and speaking up for those who cannot speak for themselves. Eliisa was able to share the need for churches to step up and stand firm for life, and to encourage the formation of *life disciples* within each church. The program equips churches to be a safe, non-judgemental place for someone facing a pregnancy decision.

Under the leadership of Seigle and PHC Exec Director Shari Boley, Livingston County now has 50 trained life disciples in 23 churches.

Following this presentation, it is our hope that Monroe County will take up the vision to encourage and train their churches with the Making Life Disciples program.

At the event, there were three other guest speakers including testimony from a woman who had been a teenage mom, a woman who found forgiveness after an abortion, and a man who went from being a Pro-Choice atheist to a Pro-Life believer.

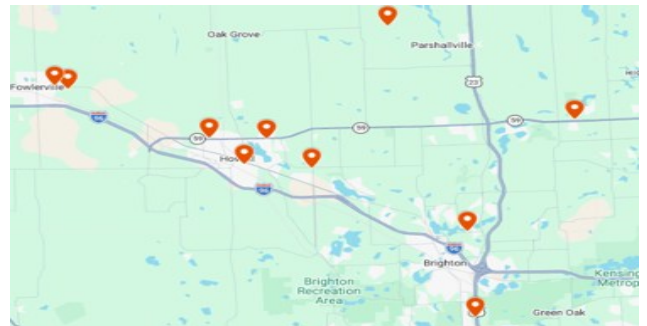
